Assessment and Question Papers pattern for 1st year students of branches having Annual pattern (except pharmacy).

Kindly refer to the subject noted above.

You are aware that Board has decided to run all the diploma courses on annual pattern with continuous evaluation for the 1st year w.e.f. 2018-19. The continuous evaluation system has been adopted for annual pattern curriculum for the 1st year in which the student shall be evaluated for 20% of the syllabus (as defined in curriculum) in the 1st Assessment, for next 20% of the syllabus (as defined in curriculum) in the 2nd Assessment and for remaining 60% syllabus in the final Assessment (Final Exam). There is 40% weightage of 1st and 2nd Assessment and hence the question papers for 1st and 2nd Assessment will be provided by the Board and evaluation will be done by the subject teachers under supervision of Board. $1^{\rm st}$ and 2^{nd} Assessment for all branches of 1^{st} year (except Pharmacy) will be got done of 40 Marks each and average of both (1st and 2nd) Assessments will be considered by the Board. The following Pattern of question papers for 1st and 2nd Assessment of 1st year student has been finalized by the Examination Committee of Board:

In this regard it is further clarified that there is 40% weightage of 1st & 2nd Assessment and these Assessments are at par with Final Examination. Hence students have to appear in the $\mathbf{1}^{\text{st}}$ and $\mathbf{2}^{\text{nd}}$ Assessment strictly as per schedule notified by the Board and in case any student miss (due to any reason) any particular assessment then being component of final exam there will be no further chance to that student
