It is notified to all concerned this office vide office order no. 349 dated 24.09.2021 was issued w.r.t. Post Matric Scholarship for Minority, AICTE Pragati Scholarship Scheme, AICTE Saksham Scholarship Scheme & AICTE Swanath Scholarship Scheme for the session 2021-2022 was published on institution website www.gpmanesar.ac.in for invitation Scholarship applications on National e-Scholarship Portal under the stated scheme from the eligible students of Government Polytechnic Education Societies and the last date for invitation scholarship application under the schemes was 30.11.2021 and last date for verification of applications at the level of the institute was 15.12.2021. Time to time competent authority increased the invitation of scholarship application dates under the stated scheme upto 15.01.2022 and accordingly the last date for verification of applications at the level of the institute was extended upto 31.01.2022.

On the basis of above publication of scholarship schemes, 41 applicants applied out of which 26 application verified, 01 application rejected and 13 application made defective at institution level whereas these 13 candidates neither removed defects online nor submitted hard copy of their signed application alongwith requisite documents upto 31.01.2022 as per direction of National e-scholarship Portal.

In case 01 candidate namely Miss Sonali daughter of Sh. Ramesh Kumar the student of 1st Year ECE of this institute under application ID No. UP202122003805957 applied for scholarship i.e AICTE Pragati Scholarship Scheme. Under this scheme only those candidate are eligible who are two girls child in a family, family annual income upto Rs. 8 lac only. As per Point no. 4 of Terms & Conditions under Point no. 11 Incomplete applications will be summarily rejected. Only verified online applications will be considered for the award of scholarship. Miss Sonali Daughter of Sh. Rakesh Kumar claimed herself as residence of Uttar Pradesh uploaded her incomplete credentials i.e Residence certificate of Uttar Pradesh, Income certificate Issued By Uttar Pradesh Authority i.e Rs. 3500/- per month, Matric from Board of School Education Haryana in the year 2021 and yearly income of Rs. 42000/- whereas as per uploaded affidavit, the candidate and her father submitted that she belongs to Haryana State /other State. As per uploaded affidavit signed by both i.e. Sh. Ramesh Kumar & Miss Sonali, that in her family, they are 01 number of sister and 01 number of brother as per PPP (Parivar Pehchan Patra of Haryana). Therefore, candidate no. of times through telephonic conversation on her phone, during the visit of her father and herself in the Scholarship cell and through online scholarship portal by way of returning the application to make corrections in her already uploaded affidavit on the scholarship website i.e. on National e-Scholarship Portal else the application shall be rejected.

In view of non completion of scholarship application on her part on National e-Scholarship Portal upto 31.12.2021 and non submission signed scholarship application upto 31.12.2021 raises doubt about her residence claim after perusal of her residence certificate, Matric certificate & affidavit. The candidate belongs to two States i.e. Uttar Pradesh and of Haryana State. Moreover, after perusal of income in income certificate issued by Uttar Pradesh and perusal of affidavit, the candidate submitted that they are 01 number of sister and 01 number of brother as per PPP (Parivar Pehchan Patra of Haryana). Therefore, it can be easily inferences after perusal of already uploaded documents for AICTE Pragati Scholarship that the candidate and his father is hiding facts of other income & about residence claim. Therefore, this office finds no merit in her online scholarship application to be forwarded for recommendation for AICTE Pragati Scholarship for the session 2021-2022 upto 31.01.2022 due to non removal of defects in the scholarship application on the part of the candidate and due to non submission signed application alongwith requisite documents upto 31.01.2022.

Hence, the claim for scholarship under AICTE Pragati Scholarship Scheme of Miss Sonali daughter of Sh. Ramesh Kumar, the student of 1st Year ECE of this institute under application ID No. UP202122003805957 stands rejected.
