Subject: Regarding opening of Centralized PMS Scholarship Portal for the year 2020-21

In continuation to this office notice no. 13 dated 19/03/2021 which has been issued in reference to the letter no. 110001/154/2020 Sch(1) Dated Panchkula, the 12.03.2021 of Director General Higher education regarding Centralized Scholarship portal for PMS Scholarship as developed by IT Cell of the Higher Education Department, Haryana (harchhatravratti.highereduhry.ac.in) for the year 2020-21. The portal will remain open for PMS SC/BC/OBC upto 31.03.2021.
